

## Wilson Community College Coronavirus Aid, Relief, and Economic Security (CARES) Act Federal Higher Education Emergency Relief Fund Report Emergency Financial Aid Grants to Students January 8, 2021

- Wilson Community College (WCC) acknowledges the College's Certification and Agreement for Emergency Financial Aid Grants to Students through the CARES Act was signed and returned to the Department of Education. The College has used more than 50 percent of the funds received to provide Emergency Financial Aid Grants to Students under Section 18004(a)(1) of the CARES Act.
- 2. WCC received a total of \$718,656 through Higher Education Emergency Relief Fund, with a minimum allocation of \$359,328 to be awarded for Emergency Financial Aid Grants to students, in accordance with the College's Certification of Agreement.
- 3. As of the date of this report, the College has awarded \$464,300 in emergency grants to students.
- 4. The total number eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 who could qualify to receive Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act, was estimated to be 431 students.
- 5. As of the date of this report, a total of 197 students have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act.
- 6. The method(s) used by the College to determine which students received Emergency Financial Aid Grants, and how much they would receive under Section 18004(a)(1) of the CARES Act, are described in Attachment A.
- 7. **Attachment A** – The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they received under Section 18004(a)(1) of the CARES Act.

Of the applications submitted through 8/4/2020 in response to WCC's email and webpage solicitations WCC excluded students who:

- had not completed a 2019-20 FAFSA
- were not eligible US citizens or eligible non-citizens
- lacked a high school diploma or equivalent
- were males not registered for Selective Service
- lacked a valid Social Security number
- were coded as enrolled in an online program

Of the students remaining, each received a \$1,500 base; \$600 additional if they were parents or guardians of dependent children; \$400 additional if disruptions caused by COVID-19 delayed their education; and \$400 additional if they were enrolled half-time or more:

Attachment B – E-mail message sent to eligible students by the Director of Financial Aid on 5/1/2020:
